Organized in July 1974 by approximately 20 enlisted personnel in Lynchburg, VA. Incorporated at the First Annual Conference in March 1975 as a non-profit organization.

The first President was State Command Sergeant Major Herbert L. Lewis.

Some of the benefits and privileges that the VAA/ANGEA promoted and helped to achieve:

- State Tuition Assistance
- National Guard license plates FREE for all Guard members and Retirees (effective 1 JUL 21)
- County or City decals for no more than the cost of National Guard plates
- Up to \$3000 of National Guard pay exempt from Virginia state income taxes
- \$1,000 AD&D Life Insurance policy for all Guard members
- Scholarships sponsored by VAA/ANGEA, EANGUS and the Auxiliary

Among the many noteworthy accomplishments of EANGUS, largely attributable to the Associations grass roots and legislative efforts are:

- VA Home Loan Program for Guard and Reserve members made permanent
- DoD Dental Insurance plans for Retirees and National Guard Members
- Burial Benefits for National Guard Members
- Unlimited Commissary privileges for Guard and Reserve Members, PX privileges for Retirees
- Retirement age for pay eligibility decreased by Deployment period(s)
- Montgomery & Post 9-11 GI Bill education benefits increases and improvements
- TRICARE benefits for National Guard members who are unemployed or without employer sponsored health insurance
- Restoration of tax-deductibility of non-reimbursable expenses for travel to drill
- Extended protections under the Soldiers' and Sailors' Civil Relief Act for National Guard Members
- Increase in IADT points that can be earned in one year.
